BY AUTHORITY OF PUBLIC ACT #110 OF 2006, AS AMENDED, THE CHARTER TOWNSHIP OF PITTSFIELD, WASHTENAW COUNTY, MICHIGAN, HEREBY ORDAINS:

ZOA# 20-210 First reading to Rezone a 10.14 - acre parcel located on the east side of State Road, north of Michigan Avenue from PUD, Planned Unit Development to C-2, Regional Commercial, for parcel L -12-29-400-011, Pittsfield Township, Washtenaw County, Michigan.
