## 2020 PITTSFIELD TOWNSHIP AGREEMENT State Road Improvements between Old State Road & Ellsworth Road

THIS AGREEMENT made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2020, by and between the Township Board of Pittsfield Township (Pittsfield Township), parties of the first part, and the Board of Washtenaw County Road Commissioners (WCRC), parties of the second part.

WHEREAS, the WCRC is programmed to mill and resurface State Road between Old State Road and Ellsworth Road and construct turning lanes at Lavender Lane as part of the countywide millage program in 2020; and

WHEREAS, Pittsfield Township desires that additional improvements be made to State Road between Textile Road and Morgan Road including widening for a continuous center left-turn lane and widened shoulders, 2 foot paved and 2 foot aggregate surface; and

WHEREAS, the proper authority is provided to the parties of the agreement under the provisions in Act 51 of Public Acts of 1951, as amended.

IT IS NOW THEREFORE AGREED, the parties of the second part will complete the State Road improvements as specified herein, all in accordance with standards of the parties of the second part; and

IT IS FURTHER AGREED that the originally programmed resurfacing of the State Road between Old State Road and Ellsworth Road will be funded by the countywide millage program and the additional work described herein between Textile Road and Ellsworth Road will be funded by Pittsfield Township; and

IT IS FURTHER AGREED, on June 1, 2020, the WCRC will submit an invoice to Pittsfield Township for 40% of the estimated costs of said improvements for Pittsfield Township's portion of the project costs. On August 1, 2020, the WCRC will submit a second invoice for an additional 40% of the same costs. Following a final accounting of the Project costs, the WCRC will submit a final invoice for the actual remaining unpaid costs on November 1, 2020. Pittsfield Township agrees to remit payment within 30 days from receipt of each invoice.
