Review of Notable Crime Activities February 1, 2020 - February 29, 2020

- > Zero Homicides occurred this February, as well as last February. YTD, homicides have remained the same. (0 this year compared to 0 last year).
- > Zero (0) Criminal Sexual Conduct (CSC) offenses occurred this February, as well as last February. YTD, CSC offenses have increased 200% (3 this year compared to 1 last year).
- ➤ Three (3) Robberies occurred this February compared to two (2) last February showing an increase of 50%. YTD, robberies have increased 33.33% this year compared to the same time last year (4 this year compared to 3 last year).
- ➤ Four (4) Aggravated Assaults occurred this February compared to three (3) last February showing an increase of 33.33%. YTD, aggravated assaults have remained the same (6 this year compared to 6 last year).

- Four (4) Burglaries Residential occurred this February compared to three (3) last February showing an increase of 33.33%. YTD, residential burglaries have decreased 42.86% this year from the same time last year (4 this year compared to 7 last year).
- ➤ Zero (0) Burglaries All Other occurred this February compared to three (3) last February showing a decrease of 100%. YTD, Burglaries All Other have decreased 33.33% this year from the same time last year (2 this year compared to 3 last year).
- ➤ Ten (10) Larcenies occurred this February, as well as last February. YTD, larcenies have decreased 8% this year compared to the same time last year (23 this year compared to 25 last year).
- Larcenies from Vehicles increased 66.67% this February (5) compared to last February (3). YTD, larcenies from vehicles increased 44.44% this year from last year (13 this year compared to 9 last year).
- ➤ One (1) Motor Vehicle Theft (MVT) occurred this February compared to five (5) last February showing a decrease of 80%. YTD, MVT decreased 22.22% this year from last year (7 this year compared to 9 last year).
- ➤ Seven (7) Malicious Damage of Property (MDOP) incidents occurred this February compared to six (6) last February showing an increase of 16.67%. YTD, MDOP offenses have decreased 25% this year from last year (12 this year compared to 16 last year).
- ➤ Drug/Narcotic violations increased 7.69% this February (14) compared to last February (13). YTD, drug/narcotic violations decreased 3.85% this year from last year (25 this year compared to 26 last year).
- ➤ Ten (10) Operating under the Influence (OUI) arrests occurred this February compared to six (6) last February showing an increase of 66.67%. YTD, OUI arrests have increased 33.33% this year from the same time last year (16 this year compared to 12 last year).
