**WHEREAS**, the Drug Law Enforcement Fund is used in any local unit of government that has budgetary authority over an agency that may seize property involved in the violation of controlled substances statutes, 1985 PA 135, MCL 333.7523 to MCL 333.7524; and

**WHEREAS**, the authorized expenditures include expenses of seizure, forfeiture and sale of property. The balance remaining must be used to enhance law enforcement efforts; and

**WHEREAS**, the cash and investments of the Drug Law Enforcement Fund are subject to the requirements of 1943 PA 20, MCL 129.91 and may be included in pooled cash and investment accounts; and

**WHEREAS**, the Drug Law Enforcement Fund must operate only with an adopted budget by the governing body of the local unit as required by 1968 PA 2, MCL 141.421 to MCL 141.440a; and

**WHEREAS**, all claims the county or local unit board pursuant to MCL 41.75 must approve (expenditures);

**NOW THEREFORE BE IT RESOLVED**, that the Township Board will approve separate Special Revenue Fund 265, Drug Law Enforcement Fund effective January 1, 2020.
