RESOLUTION TO SET UTILITY RATES

November 18, 2020

At a Regular Meeting of the Township Board of Pittsfield Charter Township, Washtenaw County, Michigan, held at the Township Administration Building located at 6201 W. Michigan Avenue, in said Township, on the 18th day of November, 2020 at 6:30 p.m.

The following preamble and resolution were offered by _____ and supported by _____.

WHEREAS, Section 36-6 of the Pittsfield Charter Township Code provides that for service and benefits furnished by the System, as defined in the ordinance, there shall be rates, benefit charges, improvement charges, tap charges, transportation charges, fire hydrant service charges and fees in the amounts as shall be determined by resolution of the township Board of Trustees; and

WHEREAS, Section 36-11 of the Code provides that township Board of Trustees shall at least annually review all rates, charges and fees provided in this article, and make such revisions as shall appear proper under the circumstances; and

WHEREAS, the Director of Utilities and Municipal Services has reviewed the operational condition of the Department of Utilities and Municipal Services and has recommended adoption of the rates set forth below;

NOW THEREFORE BE IT RESOLVED, that all current rates, charges, and fees regarding sewer and water rates shall remain in effect and unchanged except as set forth below:

SEWER USER RATES

For sewer service furnished by the system, user rates for each single-family dwelling unit shall be \$4.50 for each unit of metered water.

For sewer service furnished by the system, user rates for commercial properties shall be \$5.17 for each unit of metered water.

WATER USER RATES

For water service furnished by the system, user rates for each single-family dwelling unit shall be \$5.15 for each unit of metered water.

For water service furnished by the system, user rates for commercial properties shall be \$5.15 for each unit of metered water.
