# Board Meeting Notes for November 18, 2020 - Quarterly Cash Balance

Good Evening, as Treasurer, I am providing a summary of the investment activities as required by state law governing the investment of surplus funds. Public Act 20 Stipulates that the investment officers shall provide a written report quarterly to the governing body concerning the investment of funds.

As you can see, we had a significant increase of funds in our accounts from the second quarter. This is due to the collection of the summer taxes that started at the beginning of the third quarter. The percentage of taxes collected in past years remains consistent at 98%. We distributed the funds to the appropriate local taxing authorities.
