WHEREAS, the capital project funds are used to account for the acquisition or construction of major capital assets by a governmental unit that are not accounted for by proprietary funds and trusts; and

WHEREAS, the Ann Arbor-Saline and Oak Valley Intersection Improvement Fund is used to account for the construction of two right-turn lanes on Oak Valley Dr. at Ann Arbor-Saline Rd and installation of a traffic signal mast arms; and

WHEREAS, the Ann Arbor-Saline and Oak Valley Intersection Improvement Fund is used to account for the construction of capital asset not funded by the issuance of debt; and

WHEREAS, the Ann Arbor-Saline and Oak Valley Intersection Improvement Fund may be established by resolution of the governing body of the county or local unit. It accounts for the assets, liabilities, revenue, and expenditures authorized by the Township Board; and

WHEREAS, the monies to support this project will come from the General Fund for design, engineering and construction costs; and

WHEREAS, all claims the county or local unit board pursuant to MCL 46.11 (g), 46.71, 46.53 and 46.63, must approve (expenditures);

NOW THEREFORE BE IT RESOLVED, that the Township Board will approve separate capital project fund number 423 for the Ann Arbor-Saline and Oak Valley Intersection Improvement Fund effective August 12, 2020.
