Review of Notable Crime Activities December 1, 2020 – December 31, 2020

- > Zero (0) Homicides occurred this December, as well as last December. YTD, homicides have remained the same this year compared to the same time last year. (1 this year compared to 1 last year).
- > Zero (0) Criminal Sexual Conduct (CSC) offenses occurred this December compared to one (1) last December showing a decrease of 100%. YTD, CSC offenses have increased 20% (24 this year compared to 20 last year).
- ➤ One (1) Robbery occurred this December compared to two (2) last December showing a decrease of 50%. YTD, robberies have increased 18.18% this year compared to the same time last year (13 this year compared to 11 last year).
- ➤ Six (6) Aggravated Assaults occurred this December compared to two (2) last December showing an increase of 200%. YTD, aggravated assaults have increased 15.38% this year compared to the same time last year (45 this year compared to 39 last year).

- ➤ Four (4) Burglaries Residential occurred this December compared to zero (0) last December showing an increase of 400%. YTD, residential burglaries have decreased 31.43% this year from the same time last year (24 this year compared to 35 last year).
- ➤ Zero (0) Burglaries All Other occurred this December compared to two (2) last December showing a decrease of 100%. YTD, Burglaries All Other have decreased 5% this year compared to the same time last year (19 this year compared to 20 last year).
- ➤ Ten (10) Larcenies occurred this December compared to nine (9) last December showing an increase of 11.11%. YTD, larcenies have decreased 5.63% this year compared to the same time last year (134 this year compared to 142 last year).
- ➤ Twelve (12) Larcenies from Vehicles occurred this December compared to fifteen (15) last December showing a decrease of 20%. YTD, larcenies from vehicles decreased 51.5% this year from the same time last year (97 this year compared to 200 last year).
- ➤ Seven (7) Motor Vehicle Thefts (MVT) occurred this December compared to two (2) last December showing an increase of 250%. YTD, MVT decreased 31.15% this year from the same time last year (42 this year compared to 61 last year).
- Five (5) Malicious Damage of Property (MDOP) incidents occurred this December compared to seven (7) last December showing a decrease of 28.57%. YTD, MDOP offenses have increased 4.55% this year compared to the same time last year (92 this year compared to 88 last year).
- > Drug/Narcotic violations increased 14.29% this December (16) compared to last December (14). YTD, drug/narcotic violations decreased 25.8% this year from the same time last year (138 this year compared to 186 last year).
- ➤ Six (6) Operating under the Influence (OUI) arrests occurred this December compared to five (5) last December showing an increase of 20%. YTD, OUI arrests have decreased 20.997% this year from the same time last year (64 this year compared to 81 last year).
