Pursuant to your direction, bids for the above-referenced project were received at the Clerk's Office on Friday, January 8, 2021, where they were opened and read aloud at 11:00 AM. A total of two (2) bids were received, ranging from a low bid in the amount of \$45,028.83 for the base bid, submitted by Burman's Tree Service (Burman's) of Chelsea, Michigan to a high bid in the amount of \$90,000.48 for the base bid submitted by Davey Tree Experts Co. (Davey) of Canton, Michigan. A bid tabulation has been enclosed summarizing all of the bids that were received for the project.

In addition, Stantec has reviewed Burman's references and completed work list and verified their experience on similar projects.

Based on our review of the provided references, and the bids received, we believe that Burman's has the ability to perform the work satisfactorily on this project. Burman's is therefore deemed the lowest responsive, responsible bidder for the above referenced project (i.e., base bid) in the amount of FORTY-FIVE THOUSAND, TWENTY-EIGHT and 83/100 Dollars (\$45,028.83).
