Dear Board of Trustees and Supervisor Grewal,

My name is Anne Fortunato, I live at 4817 Sandstone Pass in Pittsfield Township and I'm a Pittsfield Township Park Commissioner. As a Park Commissioner I'm growing concerned about the lack of signage on Campbell, Payeur, Morgan and Stone School Roads to indicate that they are not truck routes. These roads border one of our most precious Pittsfield Township resources - the Pittsfield Preserve. Trucks, per the township ordinance, are not to be using these roads as truck routes. However, without signage, that may not be widely known and cannot be enforced.

From an environmental and recreational perspective, diesel engines from these trucks cause a myriad of problems. These vehicles are the largest mobile source of nitrogen oxide, a pollutant linked to heart and lung disease. Nitrogen oxide is also known to cause damage to trees and other foliage. Additionally, I have growing concerns we are damaging these roads, which may prevent people from having access to one of the most important parks in our area.

Today, I am requesting that the signage on Campbell, Payeur, Morgan and Stone School Roads, be posted immediately. Our township ordinance indicates that these are not truck routes and should be treated accordingly.

Currently 118 are still delinquent. A final demand letter was mailed on March 6th with a due date of March 31st after which we will then pursue further collections options.

Personal property taxes are the responsibly of the Township Treasurer to collect.

My office will continue its due diligence in resolving the delinquent personal property taxes.
