 - a. The Board of Trustees is meeting electronically due to the state of emergency declared by the Washtenaw County Board of Commissioners;
 - b. The public may participate by zoom, with links and phone numbers posted on the website;
 - c. Members of the public may contact members of the Board of Trustees prior to the meeting. Contact information for the Board may be found at www.pittsfield-mi.gov/118/Board-of-Trustees
 - d. Persons with disabilities may participate in the meeting by contacting the clerk's office at 734-822-3120 for assistance.
- 3. For electronic meetings:
 - a. Each member of the Board of Trustees attending the electronic meeting will participate by Zoom and shall ensure the member has two-way communication.
 - b. Each member shall, at the outset of the meeting, state that the member is attending remotely and, if not absent for military duty, state the county and city, township, or village from which the member is attending the meeting remotely.
 - c. Members of the public will be provided the information listed in Section 2, above by posting on the Township website, including the information regarding how to contact members of the Board of Trustees in advance of the meeting.
