**RESOLUTION PERMITTING STAFF
TO PURCHASE ADDITIONAL MERS SERVICE CREDIT**

At a regular meeting of the Pittsfield Charter Township Board of Trustees ("Township") held on the 11th day of July, 1995, at 7:30 p.m. at the Township Hall located at 701 W. Ellsworth Road, Ann Arbor, Michigan.

The following preamble and resolution was offered by Member Van Nest and supported by Member Aldrich.

WHEREAS, in accordance with the 1995 Municipal Employees Retirement Systems (MERS) retirement booklet the employees of Pittsfield Charter Township will be permitted to purchase prior governmental/military service time. Employees who choose to purchase either of the service times will be required to pay the employers and employees cost; and

WHEREAS, there is no limit on the years of governmental service that can be purchased and employees are not required to have 10 years of service to purchase this service time. Future amendments to Public Act 427 P.A. 1984 could change this language for purchasing governmental service time, and

WHEREAS, employees who wish to purchase military time must have 10 years of credited service with their employer to purchase 5 years or less of military time.

NOW, THEREFORE, BE IT RESOLVED, that the Pittsfield Charter Township Board of Trustees approves for employees to purchase prior governmental service time at no expense to Pittsfield Township, and

BE IT FURTHER RESOLVED, that employees are required to contact the MERS office to request the employees costs associated with purchasing prior service.


