**WHEREAS**, at a regular meeting of the Pittsfield Charter Township Board of Trustees held on July 22, 2008 a resolution was adopted creating an agreement between Pittsfield Charter Township and Northfield Township, whereby Pittsfield Township agreed to oversee the Northfield Township Building Department, providing a qualified Building Official and qualified inspectors staffed by Pittsfield Charter Township; and

**WHEREAS**, at a regular meeting of the Pittsfield Charter Township Board of Trustees held on December 8, 2009 a resolution was adopted creating an agreement between Pittsfield Charter Township and Northfield Township which designated the Building Official of Pittsfield Charter Township to act as the designated Zoning Enforcement Agent for Northfield Township; and

**WHEREAS**, for the past several years Pittsfield Charter Township has provided Building Department services and personnel, as well as Zoning Official services and personnel, according to fee schedules established in each respective agreement; and

**WHEREAS**, it is no longer beneficial to the Township to provide Building Department services nor Zoning Official services to Northfield Township;

**NOW THEREFORE BE IT RESOLVED**, that the Pittsfield Charter Township Board of Trustees hereby authorizes the termination of the agreements between Pittsfield Charter Township and Northfield Township for Building Department services and Zoning Official Services effective upon adoption of this resolution.
