Dear Supervisor Grewal,

We are the owners of the Uptown Ann Arbor mixed-use development, located at the corner of Ann Arbor-Saline Road and Oak Valley Drive. We are writing to express our disapproval towards the possible relocation of the proposed Township Park, located at the corner of Oak Valley and Waters Rd. We feel that a relocation of the park will be detrimental to our neighborhood. The Ann Arbor-Saline / Oak Valley Neighborhood was designed by the Township to be an area of density, and access to the Township Park by the greatest number of people was always a central goal for this neighborhood. Relocating the Park away from the greatest sources of density, foot traffic and commerce, towards an area of low-density homes, runs counter to the goals that the Township has set for this area, dating back to the time when the Park was purchased several years ago.

In addition, our residents have moved into Uptown Ann Arbor with the expectation of the Park being right next door. The ability to walk to the park was supposed to be a great amenity for our residents to enjoy. A relocation of the Park would make accessing the Park much more difficult for our residents.

We hope that you will take our views into account as the process for the proposed relocation moves forward. Thank you for letting us voice our opinions.
