**MEADOWS OF ARBOR RIDGE PHASE I
STREET LIGHTING SPECIAL ASSESSMENT DISTRICT
RESOLUTION NO. 1**

July 14, 2021

At a Regular Meeting of the Township Board of Pittsfield Charter Township, Washtenaw County, Michigan, located at the Township Administration Building, 6201 W. Michigan Avenue, in said Township, on the 14th day of July, 2021 at 6:30 p.m.

The following preamble and resolution were offered by _____ and supported by _____.

WHEREAS, Lombardo Homes, the developer of the Meadows of Arbor Ridge Phase I subdivision, contacted the township in 2016 with a request that streetlights be installed prior to completion of the development, in compliance with their approved site plan; and

WHEREAS, upon the township's request, DTE Energy reviewed the Meadows of Arbor Ridge Phase I subdivision and proposed to install five 52W LED colonial fixtures on direct buried 14' fiberglass posts, which were to be furnished and owned by said Company, and such charge was to include full service of the system, including general maintenance and cleaning, bulb and glass replacement, pole repair and replacement, electrical maintenance, and vandalism repair; and

WHEREAS, this Board has the power and authority pursuant to Act 188, Public Acts of Michigan of 1954, as amended, on its own motion and without petition to have exercised the powers granted by said Act 188 with respect to providing such street lighting; and

WHEREAS, this Board determined that it was conducive to the public health, safety, and welfare of the residents within the Meadows of Arbor Ridge Phase I subdivision that streetlighting fixtures be installed; and

WHEREAS, on May 10, 2017 the township Board of Trustees authorized the Supervisor and Clerk to enter into an agreement with DTE Energy for the purchase and installation of five streetlights in Meadows of Arbor Ridge Phase I, paid for by the developer in the amount of \$5,488; and

WHEREAS, Lombardo Homes provided payment to the township in the amount of \$5,488 for the installation of streetlights, which the township subsequently transferred to DTE Energy upon execution of the agreement; and

WHEREAS, the township has borne the energy and maintenance costs associated with operating these streetlights since they were installed and energized in October of 2017, as a Special Assessment District (SAD) has yet to be established; and

WHEREAS, the creation of a street lighting SAD for the Meadows of Arbor Ridge Phase I subdivision would allow for the equitable distribution of annual operating costs, most recently totaling \$1,969.80, which will be distributed evenly amongst the residents of said subdivision;

NOW THEREFORE BE IT RESOLVED,

1. The plan showing the streetlight locations and annual cost estimate of providing such streetlighting shall be filed with the Township Clerk and be available for public inspection.
2. Periodic redeterminations of cost will be necessary without a change in the special assessment district, and such redeterminations may be made without further notice to record owners or parties with interest in the property.
3. The Township Board determines that the special assessment district against which the cost of such street lighting shall be assessed, consists of all land within the Meadows of Arbor Ridge Phase I subdivision, bearing parcel numbers L -12-13-310-001, L -12-13-310-002, L -12-13-310-003, L -12-13-310-004, L -12-13-310-005, L -12-13-310-006, L -12-13-310-007, L -12-13-310-008, L -12-13-310-009, L -12-13-310-010, L -12-13-310-011, L -12-13-310-012, L -12-13-310-013, L -12-13-310-014, L -12-13-310-015, L -12-13-310-016, L -12-13-310-017, L -12-13-310-018, L -12-13-310-019, L -12-13-310-020, L -12-13-310-021, L -12-13-310-022, L -12-13-310-023, L -12-13-310-024, L -12-13-310-025, L -12-13-310-026, L -12-13-310-027, L -12-13-310-028.
4. The Township Board shall hold a virtual public hearing on Wednesday, August 11, 2021 at 6:30 p.m., to hear any objections which may be offered against the creation of such special assessment district.
5. The Township Clerk is hereby ordered to cause a notice of such hearing to be published twice, the first publication being at least ten (10) days before the time of the hearing in a newspaper of general circulation in the district, and to cause notice of said hearing to be mailed by first class mail to each owner or party interested in property in the special assessment district whose name appears upon the last tax assessment records of the Township, at least ten (10) days before the date of such hearing.
6. Said notice shall be in substantially the following form:

PLEASE TAKE NOTICE that the Township Board of Pittsfield Charter Township has provided street lighting within the Meadows of Arbor Ridge Phase I Neighborhood, consisting of five 52W LED colonial streetlight fixtures on 14' fiberglass poles which were installed and energized in October of 2017, and has tentatively designated the special assessment district against which the operating cost of street lighting is to be assessed as consisting of the Meadows of Arbor Ridge Phase I Neighborhood, lots bearing the parcel ID numbers listed above.

Plans and estimates for said street lighting have been prepared and are on file with the Township Clerk for public examination at 6201 W. Michigan Avenue, Ann Arbor, MI 48108, Monday - Friday, 8:00 a.m. - 5:00 p.m., or by emailing clerk@pittsfield-mi.gov.

Any person having an interest in this matter may be heard at this meeting. Written comments can be submitted to the Township Clerk at the address or email listed above. All comments must be received no later than 3:00 p.m. the day of the hearing.

TAKE FURTHER NOTICE that the Township Board, located at 6201 W. Michigan Avenue, Ann Arbor, MI 48108, will hold a virtual public hearing on Wednesday, August 11, 2021 at 6:30 p.m. for the purpose of hearing any objections which may be offered against creating the district and defraying the expenses thereof by special assessment. Further instructions on participating in public comment will be provided once the meeting has been called to order in order to ensure two-way communication between the Township Board and members of the public.

Appearance and protest at the hearing in the special assessment proceedings is required in order to appeal the amount of the special assessment to the state tax tribunal. An owner or party in interest, or his or her agent may appear in person at the hearing to protest the special assessment, or may file his or her appearance or protest by letter and his or her personal appearance shall not be required. Written protests shall be filed with the Township Clerk before the hearing.

If written objections are filed, in writing, prior to the hearing by the record owners of land constituting more than 20% of the total land area in the proposed special assessment district, the Township Board shall not create the district or assessments and all proceedings for the formation of the district or assessments shall be terminated.

Periodic redeterminations of cost will be necessary without a change in the special assessment district, and such redeterminations may be made without further notice to record owners or parties in interest in the property.
