**WHEREAS,** The Federal authorization of one-time stimulus funding to local units of government was approved earlier this year under the American Rescue Plan Act; and

**WHEREAS,** The determination of funding allocation to local units, termed Non-Entitlement Unit of Local Government (NEU), was announced last month; and

**WHEREAS,** Per the attached documentation and according to the Michigan Township Association, acceptance of these stimulus funds, termed Coronavirus Local Fiscal Recovery Funds (CLFRF), must be authorized by the NEU's Chief Administrative Officer and its legislative board/Board of Trustees; and

**WHEREAS,** We want there to be no ambiguity in Pittsfield Township's desire to accept the \$4,073,805 in CLFRF monies allocated to it as part of the American Rescue Plan Act;

**NOW THEREFORE BE IT RESOLVED,** That the Pittsfield Charter Township Board of Trustees votes to accept and receive \$4,073,805 of CLFRF, which includes acceptance of the terms and conditions (attached) outlined for expenditure of the same.
