AN ORDINANCE TO AMEND THE PITTSFIELD CHARTER TOWNSHIP ZONING ORDINANCE

BY AUTHORITY OF PUBLIC ACT #110 OF 2006, AS AMENDED, THE CHARTER TOWNSHIP OF PITTSFIELD, WASHTENAW COUNTY, MICHIGAN, HEREBY ORDAINS:

ZOA #21-218 is a major amendment to the existing parcels L-12-15-250-005; L-12-15-250-006; L-12-15-300-003; L-12-15-300-005; L-12-15-400-007; and L-12-15-250-400-008 to convert area in the Wheeler Center that is designed from composting to a solar field, in Pittsfield Charter Township, Washtenaw County, Michigan.

The Planning Commission held a public hearing on February 20, 2020. After holding a public hearing, considering the planners report, and considering public testimony, the Planning Commission directed staff to draft the necessary resolutions of approval. The Planning Commission found that the Planned Unit Development standards were met. On February 20, 2020, the Planning Commission voted 5-0 to recommend the resolutions of approval of the proposed Planned Unit Development for the Board of Trustees consideration.
