**WHEREAS**, pursuant to P.A. 198 of 1974, M.C.L. 207.551 et seq., a Resolution to Establish Industrial Development District #8, dated February 22, 1983, which included the property located at 4788 Runway Boulevard, Ann Arbor, MI 48108, was approved by the Pittsfield Charter Township Board of Trustees; and

**WHEREAS**, on December 12, 2018, the Pittsfield Charter Township Board of Trustees approved an Industrial Facilities Exemption Certificate now identified as IFT #2019-013 for Pacific Industrial Development Corporation in the amount of \$8,000,000 for real property and \$4,600,000 for personal property for twelve (12) years; and

**WHEREAS**, Pacific Industrial Development Corporation provided documentation in July 2021 that they will not proceed with building the new facility located at 4788 Runway Boulevard, and therefore completion of the facility will not occur within two years after the effective date of the certificate;

**NOW THEREFORE BE IT RESOLVED** that the Pittsfield Charter Township Board of Trustees requests that the Michigan State Tax Commission revoke Industrial Facilities Exemption Certificate #2019-013 for Pacific Industrial Development Corporation for real and personal property located at 4788 Runway Boulevard.
