WHEREAS, The Pittsfield Charter Township Local Officials Compensation Commission determines the salaries of elected officials pursuant to the Pittsfield Township Code and MCL 42.6a; and

WHEREAS, The Compensation Commission meets in odd-numbered years to determine salaries for the two years following the determination; and

WHEREAS, As such, the Compensation Commission is scheduled to meet in 2021 to discuss the salaries of the seven members of the Board of Trustees and five members of the Park Commission; and

WHEREAS, Given the failure of the 3.95 Public Safety millage in May and ongoing uncertainty about the same, it would be fiscally careless and imprudent for elected officials to accept any salary increases; and

WHEREAS, If the Board of Trustees, which is authorized with making the final decision on the Compensation Commission's recommendation, is in agreement with freezing salaries of elected officials in keeping with what has been in effect, for the most part, for union and non-union team members;

NOW THEREFORE BE IT RESOLVED, That the Pittsfield Charter Township Board of Trustees thanks the Local Officers Compensation Commission for its dedication and thoughtfulness over the years and recognizes the extensive data collection and analysis done by staff and the Commission in preparation of its determinations;

BE IT FURTHER RESOLVED, That the Board of Trustees requests that, considering the abovementioned fiscal hardships currently being faced by Pittsfield Township, the Compensation Commission forgo its usual data collection and analysis and immediately determine there should be no increase in salaries for Pittsfield Township elected officials for the next two years.
