**RESOLUTION TO COMMEMORATE THE TWENTIETH ANNIVERSARY OF THE
TERROR ATTACKS ON SEPTEMBER 11TH, 2001**

At a Regular Meeting of the Township Board of Pittsfield Charter Township, Washtenaw County, Michigan, located at the Township Administration Building, 6201 W. Michigan Avenue, in said Township, on the 8th day of September, 2021 at 6:30 p.m.

The following preamble and resolution were offered by _____ and supported by _____.

WHEREAS, September 11, 2021, marks the 20th Anniversary of the terrorist attacks that forever changed our Country and the world; and

WHEREAS, We honor the memory of those who lost their lives in those devastating attacks on our Nation, memories that will forever remain with their families and will live in the hearts of every American; and

WHEREAS, To those who were lost and the loved ones they left behind, and to those who were there to help, we will never forget; and

WHEREAS, On the morning of Tuesday, September 11, 2001, terrorists hijacked four airplanes and carried out suicide attacks against targets in the United States; two of the planes were flown into the Twin Towers of the World Trade Center in New York City, a third plane hit the Pentagon just outside Washington, D.C., and the fourth plane crashed in a field in Shanksville, Pennsylvania; and

WHEREAS, These attacks resulted in 2,977 civilian fatalities, over 25,000 injuries, including countless first responders who have died or continue to suffer from illnesses related to serving at Ground Zero; and

WHEREAS, Of those who perished during the attacks and the subsequent collapses of the towers, 343 were New York City firefighters, 23 were New York City police officers and 37 were officers at the Port Authority; and

WHEREAS, Every American remembers where they were on the morning of September 11, 2001, when they heard about the attacks; and no matter age, race or religion we were all affected; and

WHEREAS, On September 11, 2021, we will come together as a nation to remember and pay homage to the many brave men and women who lost their lives on the frontlines of duty not just on September 11, 2001 but over the course of these past twenty years in order to defend our freedoms and democracy,

NOW THEREFORE BE IT RESOLVED, That this Board of Trustees pause in its deliberations to commemorate the 20th Anniversary of the 9/11 terrorist attacks on our Nation.
