The following preamble and resolution were offered by	and supported by	_

WHEREAS, the Federal Coronavirus Local Fiscal Recovery Fund (CLFRF) was established under section 9901 of the American Rescue Plan Act of 2021 (ARPA). The fund provides substantial funding to local governments by either federal direct payments to Metropolitan Cities and Counties or state payments to Non-Entitlement Units of Local Government (NEU's). This fund is subject to laws, rules, regulations, and orders of the local jurisdiction governing the use of public funds; and

WHEREAS, the authorized expenditures as of March 3, 2021 to include expenses allowed in four different categorizes, 1) Response to public health emergency or its negative economic impacts, 2) Provide premium pay for essential workers - within caps, 3) Provide government services to the extent of lost revenue and 4) Investments in water, sewer, or broadband infrastructure. The funds must be obligated by December 31, 2024 and expended by December 31, 2026; and

WHEREAS, the cash and investments of the American Rescue Plan Act Fund (ARPA) are subject to the requirements of 1943 PA 20, MCL 129.91 and may be included in pooled cash and investment accounts; and

WHEREAS, the American Rescue Plan Act Fund (ARPA) must operate only with an adopted budget by the governing body of the local unit as required by 1968 PA 2, MCL 141.421 to MCL 141.440a; and

WHEREAS, all claims the county or local unit board pursuant to MCL 41.75 must approve (expenditures);

NOW THEREFORE BE IT RESOLVED, that the Township Board will approve separate Special Revenue Fund 285, Federal Forfeiture Fund effective March 3, 2021.
