### **Review of Notable Crime Activities September 1, 2021 – September 30, 2021**

Note: 2021 activity is compared to the activity of 2019 due to COVID-19

- Zero (0) Homicides occurred this September compared to one (1) in September of 2019 showing an increase of 100%. YTD, homicides have increased 100% this year compared to 2019. (0 this year compared to 1 in 2019).
- Two (2) Criminal Sexual Conduct (CSC) offenses occurred this September compared to five (5) in September of 2019 showing a decrease of 60%. YTD, CSC offenses have increased 13.33% this year compared to 2019 (17 this year compared to 15 in 2019).
- One (1) Robberies occurred this September as well as in September of 2019. YTD, robberies have decreased 12.5% this year compared to 2019 (7 this year compared to 8 in 2019).
- Seven (7) Aggravated Assaults occurred this September compared to three (3) in September of 2019, showing an increase of 133.33%. YTD, aggravated assaults have increased 8.82% this year compared to 2019 (37 this year compared to 34 in 2019).

- One (1) Burglary – Residential occurred this September compared to five (5) in September of 2019, showing a decrease of 80%. YTD, residential burglaries have decreased 64.52% this year from the same time in 2019 (11 this year compared to 31 in 2019).
- Zero (0) Burglaries – All Other occurred this September compared to two (2) in September of 2019, showing a decrease of 100%. YTD, Burglaries – All Other have decreased 13.33% this year compared to the same time in 2019 (13 this year compared to 15 in 2019).
- Seventeen (17) Larcenies occurred this September compared to eleven (11) in September of 2019, showing an increase of 54.55%. YTD, larcenies have decreased 6.31 % this year compared to the same time in 2019 (104 this year compared to 111 in 2019).
- Ten (10) Larcenies from Vehicles occurred this September compared to nineteen (19) in September of 2019, showing a decrease of 47.37%. YTD, larcenies from vehicles decreased 25.81% this year from the same time in 2019 (115 this year compared to 155 in 2019).
- Four (4) Motor Vehicle Thefts (MVT) occurred this September compared to three (3) in September of 2019, showing an increase of 33.33%. YTD, MVT decreased 34.69% this year from the same time in 2019 (34 this year compared to 49 in 2019).
- Five (5) Malicious Damage to Property (MDOP) incidents occurred this September compared to seven (7) in September of 2019, showing a decrease of 28.57%. YTD, MDOP offenses have decreased 7.25% this year compared to the same time in 2019 (64 this year compared to 69 in 2019).
- Drug/Narcotic violations increased 45.45% this September (16) compared to September of 2019 (11). YTD, drug/narcotic violations decreased 2.2% this year from the same time in 2019 (133 this year compared to 136 in 2019).
- Twelve (12) Operating under the Influence (OUI) arrests occurred this September compared to ten (10) in September of 2019, showing an increase of 20%. YTD, OUI arrests have increased 9.8% this year compared to the same time in 2019 (67 this year compared to 61 in 2019).
