TOWNSHIP OF PITTSFIELD, WASHTENAW COUNTY, MICHIGAN, HEREBY ORDAINS:

Parcels L-12-28-200-005 and L-12-28-200-008 in Pittsfield Charter Township, Washtenaw County, Michigan are hereby rezoned to Planned Unit Development (PUD) under the terms and conditions of the approved Sutherland Square Planned Unit Development Site Plan, the August 19, 2021 Planning Commission Resolution of approval and the Sutherland Square PUD Agreement.
