**NOTICE IS HEREBY GIVEN** that an electronic meeting of the Pittsfield Township Board of Trustees, located at 6201 W. Michigan Avenue, Ann Arbor, MI 48108, will be held on Wednesday, December 8, 2021 at 6:30 p.m.

At this meeting, the Township Board will hold a Public Hearing, ZOA #21-219, on a proposed major amendment to the existing Country Creek Village Planned Unit Development. DMFH3, LLC is proposing to construct approximately 8,000 square feet of additional commercial tenant space within two (2) structures in outlots along East Michigan Avenue. The property is located at the southeast corner of Michigan and Moon Roads, Saline, Michigan 48176, tax parcel L-12-33-200-018 in Section 33, Pittsfield Charter Township, Washtenaw County, Michigan.
