WHEREAS, the Uniform Budgeting and Accounting Act, Act 2 of 1968, Budget Sections as amended through Act 493 of 2000, 141.437 Section 17 (1) states that any deviation from the original general appropriations act shall not be made without amending the general appropriations act;

WHEREAS, the legislative body of the local unit shall amend the general appropriations act as soon as it becomes apparent that a deviation from the original general appropriations act is necessary and the amount of the deviation can be determined;

WHEREAS, an amendment shall indicate each intended alteration in the purpose of each appropriation item affected by the amendment; and,

WHEREAS, if during a fiscal year it appears that the actual and probable revenues from taxes and other sources in a fund are less than estimated revenues, amendments to the revenue appropriations shall be recommended to meet sufficient balance in the general appropriations act.

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees for Pittsfield Charter Township, the following amendments to the 2021 General Fund Budget, 2021 Fire FEMA Fund Budget, and the 2021 Building Safety Fund.

- 1. Decrease Streetlight-Twp. line item 101-448-921.001 in the amount of \$210,000, increase A2Saline-Oakvalley intersection line item 101-872-986.019 in the amount of \$201,700, increase Memberships line item 101-100-957 in the amount of \$8,300 (Re-assign 2021 Streetlight Projects to A2Saline-Oakvalley project & Leg. Dues.)
- 2. Increase Federal grants line item 214-501 in the amount of \$30,000 and increase Contributions from Local Units line item 214-580 in the amount of \$2,500 and increase Capital Expenditures line item 214-970 in the amount of \$32,500. (FEMA Funds)
- 3. Increase Building Permit Fees line item 249-476 in the amount of \$250,000 and increase Wage line item 249-706 in the amount of \$65,000, increase Fringe Benefits line item 249-712 in the amount of \$50,000 and increase Contractual Services line item 249-818 in the amount of \$135,000. (To cover Personnel vacancies)
