Board Meeting Notes May 25, 2022

Good evening everyone, I want to update you on our tax collection and settlement process. **Settlement** - is the process in which the County and the Township reconcile the tax collection and the remaining delinquent taxes. From those numbers the County reimburses the Township for the real property taxes, special assessments, and administration fees due to the Township.

- The Township submitted our settlement package to the County March 18, 2022.
- The Township is expected to receive \$380,962.37 from the County for the outstanding real property taxes, administration fees, and special assessments. The County has indicated that they have reviewed all of the settlements and that we should expect the reimbursement by early June.
- This year we collected 98.6% of the taxes levied, very similar to last year.

The graph in the packet shows the volume of funds collected for each local entity. As you can see, the amount of taxes collected for the local entities is quite substantial. The percentage of Township taxes & administration fees collected for the entirety of the tax year is only 15.8 % of the total collected. The remaining funds are distributed to the other entities listed.

The Treasurer's office strives to provide friendly and quality service to all of our residents as we prepare for the 2022 tax collection cycle.
