**WHEREAS**, this Board has the power and authority pursuant to Public Act 188 of 1954, as amended, to exercise the powers granted by said Act with respect to providing lighting to the public streets within the Township and for the recovery of costs thereof by special assessment against the properties specially benefitted; and

**WHEREAS**, this Board designated by resolution special assessment districts consisting of certain parcels of land, attached hereto as Exhibit A, against which the annual operating costs of street lighting are to be assessed; and

**WHEREAS**, to defray the annual energy and maintenance cost for the forthcoming year, it is necessary that a special assessment be levied covering all lands within the Township's special assessment districts benefitted by street lighting;

**NOW THEREFORE BE IT RESOLVED**, this Board hereby approves the sum to provide such street lighting for a period of one year, which is to be assessed upon each said parcel as attached hereto as Exhibit A, and direct the Treasurer to collect such assessments; and

**BE IT FURTHER RESOLVED**, that all other resolutions and parts of resolutions, insofar as they conflict with the provisions of this resolution, be and the same are hereby rescinded.
