Statistics for the current period are from September 1, 2022, through September 30, 2022. During that period, the Department of Public Safety saw the following activity:

Review of Notable Crime Activities September 1, 2022 – September 30, 2022

- Zero Homicides occurred this September, as well as last September. YTD, homicides have remained the same this year compared to the same time period last year (0 this year compared to 0 last year).
- Two (2) Criminal Sexual Conduct (CSC) offense occurred this September compared to three (3) last September showing a decrease of 33.33%. YTD, CSC offenses have decreased 36.84% this year compared to the same time period last year (12 this year compared to 19 last year).
- Two (2) Robberies occurred this September compared to one (1) last September showing an increase of 100%. YTD, robberies have remained the same this year compared to the same time period last year (7 this year compared to 7 last year).
- Four (4) Aggravated Assaults occurred this September compared to six (6) last September showing a decrease of 33.33%. YTD, aggravated assaults have increased 13.51% this year compared to the same time period last year (42 this year compared to 37 last year).

- Two (2) Burglaries – Residential occurred this September compared to one (1) last September showing an increase of 100%. YTD, Burglaries – Residential have increased 83.33% this year compared to the same time period last year (22 this year compared to 12 last year).
- Two (2) Burglaries – All Other occurred this September compared to zero (0) last September showing an increase of 200%. YTD, Burglaries – All Other have decreased 15.38% this year compared to the same time period last year (11 this year compared to 13 last year).
- Twenty (20) Larcenies occurred this September compared to seventeen (17) last September showing an increase of 17.65.5%. YTD, Larcenies have increased 20.75% this year compared to the same time period last year (128 this year compared to 106 last year).
- Fifteen (15) Larcenies from Vehicles occurred this September compared to ten (10) last September showing an increase of 50%. YTD, Larcenies from Vehicles have increased 11.3% this year compared to the same time period last year (128 this year compared to 115 last year).
- Six (6) Motor Vehicle Thefts (MVT) occurred this September compared to four (4) last September showing an increase of 50%. YTD, MVT offenses have increased 78.13% this year compared to the same time period last year (57 this year compared to 32 last year).
- Sixteen (16) Malicious Damage to Property (MDOP) incidents occurred this September compared to five (5) last September showing an increase of 220%. YTD, MDOP offenses have increased 34.38% this year compared to the same time period last year (86 this year compared to 64 last year).
- Drug/Narcotic violations decreased 37.5% this September (10) compared to last September (16). YTD, drug/narcotic violations decreased 40.60% this year from the same time period last year (79 this year compared to 133 last year).
- Four (4) Operating under the Influence (OUI) arrests occurred this September compared to fourteen (14) last September showing a decrease of 71.43%. YTD, OUI arrests have decreased 43.48% this year compared to the same time period last year (39 this year compared to 69 last year).
