The Township Historic District Commission is hereby established. The Commission shall 17 18 consist of seven nine members appointed by the Township Board of Trustees. Each member 19 of the Commission shall reside within the Township. A majority of the members shall have 20 a clearly demonstrated interest in or knowledge of historic preservation. Two members shall 21 be appointed from a list submitted by one or more duly organized local historic preservation 22 organizations. If such a person is available for appointment, one member shall be a graduate 23 of an accredited school of architecture who has two years of architectural experience or who 24 is duly registered in the state. 25 Terms shall be three years, except the initial appointments of some members shall be for 26 less than three years so that the initial appointments are staggered. Members shall be 27 eligible for reappointment. 28 A Commission member may be removed by the Board of Trustees due to acts or omissions 29 of that member on findings by the Board of Trustees that the acts or omissions are inconsistent with or harmful to the spirit of this chapter or to the interests of the Township. 30 31 D. Vacancies on the Commission shall be filled by the Board of Trustees within 60 days to 32 complete the unexpired term. 33 34 **SEVERABILITY** 35 36 The provisions of this Ordinance are hereby declared to be severable and if any clause, sentence, 37 word, section, or provision is declared void or unenforceable for any reason by a court with 38 competent jurisdiction, it shall not affect any portion of the Ordinance except that part or portion 39 affected by the court's decision.
