SUBJECT: Recommendation of Approval for a New On-Premises Tasting Room Permit for Mothfire Brewing Company, LLC, located at 713 W. Ellsworth.

BOARD ACTION REQUESTED: Adopt a Resolution Recommending Approval for a New On-Premises Tasting Room Permit for Mothfire Brewing Company, LLC, Resolution #22-40.

BACKGROUND: Mothfire Brewing Company, LLC is moving their business from Ann Arbor to Pittsfield Township, and will be located at 713 W. Ellsworth. Mothfire craft beer brewing company committed to “creating a cultural bonfire through craft beer, music, and art” and is requesting to operate a small tap room as an accessory use. Mothfire was granted a Conditional Use Permit by the Planning Department in June of 2022 which will provide façade, parking, and landscaping improvements.

Recommendation from the local legislative body is required for a new On-premise Tasting Room. Mothfire is requesting that the Township recommend approval.
